The Redstone Arsenal VTF is happy to assist in preparing your pet to travel during your upcoming leisure travel or PCS move. However, it is the pet owner's responsibility to ensure that all regulatory requirements are met prior to travel.

These responsibilities include, but are not limited to:

- 1) Visiting the USDA APHIS Pet Travel website to review requirements for international pet travel.
- 2) Calling the VTF with enough advance notice to schedule required appointments.
- 3) This completed form and all required vaccine/microchip records must be returned to the VTF no later than 2 weeks BEFORE your health certificate appointment.

As stated, please review the USDA APHIS Pet Travel website to ensure that your pet(s) meet those countries requirements. Some countries require specific diagnostics such as the Florescent Antibody Virus Neutralization (FAVN) test. Other country specific requirements are that your pet(s) have to receive external and internal Parasitic Treatment performed at vet prior to travel and varying quarantine regulations if needed.

Contact or review the website of the company that your pet travel will be conducting through to ensure that you and your pet are prepared to travel. Example: What crates are allowed for pet travel with United Airlines and are items allowed to be in the crate with the pet(s).
